Connie Brooks, of law firm C.E. Brooks & Associates P.C., originally requested all emails with the word "wilderness." Requester then narrowed her request to 3,500 pages already redacted and to DOI emails with phrases "lands with wilderness character," "lands with wilderness characteristics," "wildlands, or "citizen proposed wilderness." Of 14,194 responsive pages, 295 are White House Equities, mostly emails about wilderness amongst DOI employees and White House officials Jason Bordoff, Thomas Darin, Jessica Maher, Michael Block, P. Ramos, and Heather Zichal.

Richard Ha redacted all 14,194 pages and extracted the 295 pages of White House Equities. Pending consulting with two DOI field offices, the DOI OS FOIA office will send the 13,899 pages of non-White House Equities to the FOIA requester. We are forwarding to you 295 pages of redacted White House Equities approved by Solicitor Roland Blackman.

Ed,

I am again attaching the White House equities we found in this FOIA response. In re-reviewing the case, I found four more pages that should also be found as White House equities. I have attached them aswell.

In addition, I have attached the original FOIA request letter (13-00045qa).

13-00045ca is 29 pages, and it begins with an inventory of the the emails in the file. Almost all of this file is email exchanges concerning when the rule taking the Wyoming Gray Wolf off the Federal list of endangered species. Some of the names that appear more often on this list include:

Mike Lawyer
Megan Apgar
Sarah Prigan

13-00045cb is a file consisting of 27 pages. Again, there is a lot of email traffic on these files, and they largely talk about the upcoming change to the Gray Wolf's status. However, there is also a lot of exchange between DOI and Governor Mead of Wyoming, as well as with Teton County Commissioner, Hank Phibbs. **Phibbs is mostly concerned with getting an understanding of what Wyoming will be able to do visa vie trophy hunting.** Governor Mead and Daniel Ashe of DOI exchange letters concerning the size of the population of Gray Wolves in trophy/game hunting areas.

Some of the common names seen in the email traffic are: Nicholas Wills, Michael Bean, Michael Brennan of Holland & Hart, and Missy Small. There is a press release in this file, but the drafts of this press release are all

redacted.

13-00045cc is a file consisting of 163 pages. It begins with the Secretary's weekly report—an earlier draft of which has been redacted. There is a heavily redacted powerpoint on the numerous animals on the endangered species list, and there are various press releases from hunting groups, environmental groups and Wyoming state government. The end of this file has a proposed House legislation summary. The email traffic on this is heavily redacted, but the actual draft legislation is not.

OS-2012-000176: On February 13, 2012, the requester, Michael Kunzelman of the Associated Press, sought the following records:

"copies of all emails sent and received by Secretary Ken Salazar between April 20, 2010 (the date of the Deepwater Horizon rig explosion) and July 31, 2010." We located 4416 pages of records. Of the 4416 pages, 3593 have White equities.

Those pages more or less cover the entirety of the communications, schedules, press releases and legislative contacts of Secretary Salazar during the late Spring and Summer of 2010, when the Deep Water Horizon oil spill crisis was on-going. (b) (5)

While Deep Water Horizon, obviously is the main focus of Secretary Salazar's attention during that time, the email traffic indicates Secretary Salazar continued to look after his other many concerns. He reviewed drafts of the Clean Energy Jobs and Oil Company Accountability Act, the Everglades preservation Act, and the Tribal Law and Order Act. He also kept up with the daily status of the Gulf's National Parks and Fish and Wildlife facilities throughout this time period.

We are releasing a partial response to the FOIA request (2012-00080). Richard Ha, the FOIA processor, who reviewed this one, prepared the below summary. Attached to this email are the six files containing the WH equities.

On December 5, 2011, Buster Johnson, Chairman of the Mohave County Board of Supervisors, sent a FOIA requesting seeking "[a]ll email records archived and retained by the DOI from or to the [54 listed] individual email addresses dating from January 1, 2009 to the date of this letter and using the word 'withdrawal' in connection with the words 'Arizona, uranium or Grand Canyon.' . . . This request should be interpreted to include all attachments as well."

In response, the DOI OS FOIA office located and organized responsive electronic mail from 42 individuals into 42 pdf files, one pdf file for each individual. Six pdf files had joint DOI-White House records that could be interpreted

as White House equities. These six pdf files either had electronic mail sent to, from, or cc'ed White House officials; or had some discussion of White House activities.

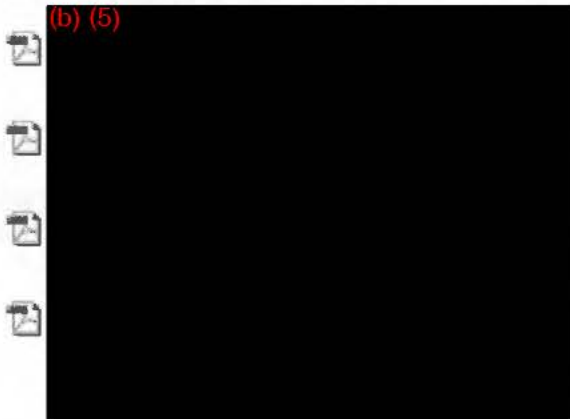
