NSHEAB Chairman Spanier has already spoken to his successor, Hunter Rawlings, the former President of the University of Iowa and Cornell University, about taking over the vacant NSHEAB slot, and President Rawlings is willing to serve. He does not have a security clearance, however, so that is something which will need to be handled. It is not expected that President Rawlings will relocate to the DC area until he actually takes over in June.

I just wanted to give you a heads-up that this is on the horizon. Once President Rawlings arrives, we'll go out with an appointment/welcome letter, and ask WFO to begin the clearance process.
