We are working on increasing patrols in that area now, and as we discussed yesterday taking additional education, monitoring, and enforcement measures. An additional example of these measures is our reporting hotline and partnership with friends of cedar Mesa to offer rewards for reports leading to prosecution of illegal activities. (I don't think we discussed that yesterday, but you may have spoken with Josh Ewing about it.) It would be speculation to confirm your assumption that monument designation would increase boots on the ground. Funding and resources are separate issues from land use designations. They don't always go hand in hand.

I'll check on the number of BLM rangers for you for GSEMN, I'm out of the office right now and should be able to get back to you in a short while. I believe the number of rangers we have is consistent with bureau wide averages on an acre basis, but will confirm that too.

No problem, I'm happy to help, and thank you for checking facts.

When fully staffed, the Monticello Office has two BLM Law Enforcement Officers. Currently one of the positions is vacant, due to a recent retirement. A job announcement for the vacant position is being filled, interviews are being conducted this week. In the interim, the Canyon Country District Supervisory Law Enforcement Ranger is assisting in the area. BLM Law Enforcement Rangers are federal officers that uphold a wide range of laws and regulations in the prevention, detection, and investigation of crimes affecting public lands resources. They also work closely with other law enforcement officers from other agencies and the local County Sheriff's Office.

We also have two full time professional archaeologists and a significant group of volunteers that serve as site stewards and help with permitting and patrols in the Kane Gulch Ranger Station in the busy season.

Q1) Acres of BLM in the proposed monument?

A: The BLM administers approximately 1.4 million acres within the proposal area based on a Bears Ears Inter-tribal Coalition proposed boundary map dated March 7, 2016.

Below is a more specific breakdown of land ownership if that's helpful.

BLM acres = 1,411,306
NPS acres = 154,722
USFS acres = 365,971
State of Utah acres = 153,036
Private acres = 17,841

Q2) Number of BLM Law Enforcement Rangers in the Grand Staircase-Escalante National Monument?

A: The answer is a bit complicated because of changes in administrative boundaries and management prior to and following monument designation. Prior to designation of the Grand Staircase-Escalante National Monument, the Kanab Field Office (approximately 2.5 million acres) had 1 ranger. That number temporarily increased but then dropped again and today, the combined area of the Grand Staircase-Escalante National Monument and Kanab Field Offices have the equivalent of about 1.5 BLM Law Enforcement Rangers.

Q3). % acres of BLM in San Juan County

The Monticello Field Office is about 1.8 million acres, but that includes land in both San Juan and the southern part of Grand County. I'm still researching if you need an exact percentage. I'll send that along, but wanted you to have answers to the first two questions now.

Thanks. Could you also confirm what percentage of the proposed monument area the BLM current manages?

We are working on increasing patrols in that area now; and as we discussed yesterday taking additional education, monitoring, and enforcement measures. An additional example of these measures is our reporting hotline and partnership with friends of cedar Mesa to offer rewards for reports leading to prosecution of illegal activities. (I don't think we discussed that yesterday, but you may have spoken with Josh Ewing about it.) It would be speculation to confirm your assumption that monument designation would increase boots on the ground. Funding and resources are separate issues from land use designations. They don't always go hand in hand.

I'll check on the number of BLM rangers for you for GSEMN, I'm out of the office right now and should be able to get back to you in a short while. I believe the number of rangers we have is consistent with bureau wide averages on an acre basis, but will confirm that too.
