PLEASE TAKE NOTICE that on February 26, 2018, GreenTech Automotive, Inc., Gulf Coast Funds Management, LLC, American Immigration Center, LLC, GreenTech Automotive Capital A-3 GP, LLC, and WM Industries Corp. (collectively, the “Debtors”) filed voluntary petitions seeking relief under Chapter 11 of Title 11 of the United States Code in the United States Bankruptcy Court for the Eastern District of Virginia, under the following case numbers:
