Dear Mr. Chairman:

This is in response to your letter of June 23, 2015, concerning potential political influence in the processing of Freedom of Information Act (FOIA) requests within the Department of Veterans Affairs from January 1, 2007, through the date of your letter. Your letter also requested a certification from the Chief FOIA Officer for the Department that no non-career officials were involved in the response to any FOIA request or if involved, the involvement never resulted in the undue delay or provision of less information than would have otherwise been provided.

VA's FOIA process is highly decentralized both in the field and in VA Central Office (VACO). The Veterans Health Administration, Veterans Benefits Administration, and National Cemetery Administration are each responsible for processing information requests within their respective organizations. Many FOIA requests are handled directly by the VA field facility where a request for information is received. Other requests are processed by various offices within VACO. There are no political appointees in VA who have responsibility for responding to FOIA requests.

The Office of Inspector General (OIG) prepared a survey that was issued to all VA FOIA officers and offices through the VA Principal Deputy Assistant Secretary for Information and Technology who serves as the VA Chief FOIA Officer. Enclosed is a sample copy of the survey questionnaire. We analyzed the responses submitted by the individuals and offices who responded to the survey. The survey asked that the respondent list the date they began working as a FOIA officer. Most of the individuals who responded had not been in their positions for the time period covered by the request.

Only one respondent stated that a political appointee was involved in the FOIA process. This was not unexpected since the majority of FOIA requests are processed in the field, not VACO, and there are no political appointees at field locations. The positive response was from an individual in the Office of the Executive Secretariat. The respondent, who has been a FOIA official since October 2010, stated that this single incident did not result in the undue delay of a response to a FOIA request or the provision of less information than would have otherwise been provided.

To complete our analysis, we reviewed contacts to the OIG Hotline to determine whether the survey results from VA FOIA officers and offices were consistent with data collected independent from the survey. We searched from fiscal year 2007 through present and did not identify any Hotline contacts related to interference by political appointees in the FOIA process.

As requested by the Committee, we obtained the enclosed certification by VA's Chief FOIA Officer stating to the best of his knowledge and based on the survey results that only one instance of involvement by a political appointee occurred, but that it did not result in undue delay or the provision of less information than would have otherwise been provided.


The Senate has also requested a written certification from the department's chief FOIA officer reflecting that for the period between January 1, 2007 to present: 1) no non-career officials were involved in the department or agency's response to any FOIA request, or 2) if such involvement occurred, the involvement of non-career officials has never resulted in the undue delay of a response to a FOIA request or the provision of less information than would have been provided but for the involvement of the non-career officials. The HSGAC has also requested a reason from any department chief FOIA officer who refuses to provide the written certification.

1. This is in response to your request on behalf of the Senate Committee on Homeland Security and Governmental Affairs concerning the involvement of Political Appointees in responding to requests under the Freedom of Information Act (FOIA). A department wide survey was conducted to determine if any VA FOIA Officers had been contacted or had their response either influenced or delayed by Political Appointees. Only one office indicated there was Political Appointee involvement in the processing of FOIA responses but that the involvement did not result in a delay of a response or the withholding of any document or portion of any document that would have otherwise been released
2. As the designated Chief FOIA Officer for the Department of Veterans Affairs, to the best of my knowledge and based on the results of this survey, for the period between January 1, 2007 to present, there was only one instance of a Political Appointee involved in the department or agency's response to any FOIA request, and the involvement of the Political Appointee did not result in the undue delay of a response to a FOIA request or the provision of less information than would have been provided but for the involvement of the non-career official.
